

Barbados

Population: 283,221

Geography: It is the most easterly of the

Caribbean islands with an area of 166.4 sq miles

- Over the span of three academic years an average of 72 students from the Masters of Forensic Science program at the University of the West Indies, some being from Barbados, have been trained in Effective Project Planning and Evaluation in Health Research, methodology developed by TDR (Special Programme for Research and Training in Tropical Diseases) and incorporated into a Research method module of this postgraduate program








Grand Cayman

Population: 52,601

Geography: It is the largest of the Cayman

Islands with an area of 76 sq miles







Grenada

Population: 105,483

Geography: It is the most southern of the Windward Islands. It is a tri-island state comprising the islands of Grenada, Carriacou and Petit Martinique with a total land area of 133 sq miles

Guyana

Population: 795,369

Geography: It is situated on the northern coast of South America and has an area of 83,000 sq miles







Jamaica

Population: 2.712 million

Geography: It is the largest English-speaking island in the Caribbean Sea and covers an area of 4,244 sq miles

Population: 180,870

Suriname

Population: 534,541

Geography: It is on the northeastern Atlantic

coast of South American and it covers an area of

63,039 sq miles







Bahamas

Population: 371,960

Geography: It is an archipelago of about 700 islands and covers an area of 5,382 sq miles






Turks and Caicos
