Steps and strategies for **governments** to strengthen civil society engagement at the national levelⁱ

Civil Society Organisations (CSOs)ⁱⁱ can play a key role in all aspects of the research process, from developing a research agenda that responds to the needs and concerns of the public, to conducting research and transforming research findings into action.

The goal of research for health is better health for all. Reaching this goal is possible with the involvement of the actors in health that represent the rich spectrum of sectors and disciplines, including CSOs

BUILDING RECOGNITION

CREATING AN ENABLING ENVIRONMENT FOR CSO ENGAGEMENT

Develop Commitment

- Advocate for CSO engagement.
 Target other policy-makers,
 researchers, funders and CSO
- Engage in dialogue with CSOs about harmonising efforts towards national policies and agendas

Lay the Foundations

- Describe the role of CSOs in national policies, plans and strategies
- Include CSOs in national priority setting processes
- Encourage participation of CSOs in conducting research on country priorities

IMPLEMENTING STRATEGIES

ENGAGING WITH CSOs

Develop Partnerships

 Establish and strengthen research partnerships and networks among CSOs, government and academia, respecting good partnership principles

Strengthen Capacity

 Support development of institutional and human capacity of CSOs, ensuring their role in national human resources plans

Secure Fundina

- Make CSO involvement a criteria for selected calls for proposals
- Increase national funds available to CSOs
- Involve CSOs in research projects and programmes where appropriate

Move from Research to Action to Policy

- Create a national web-based platform for information sharing at national level, making research findings available in a language and format useful to the general public
- Build on CSO expertise and networks for research communication
- Create a space where all researchers can present their results
