Introduction

This document provides the responses to a mapping of the National Health Research System (NHRS) of Yemen. The mapping took place as part of a joint effort between WHO EMRO, COHRED and the Gulf Cooperation Council (GCC) to inform future actions to strengthening health research governance and management in ten Mediterranean countries.

This assessment intended to build a descriptive picture of the national health research systems in four key areas:

- A. Governance and management of the National Health Research System
- B. Institutions engaged in research for health
- C. Key stakeholders involved in research for health
- D. Available literature and data review

A. GOVERNANCE and MANAGEMENT of THE NATIONAL HEALTH RESEARCH SYSTEM (NHRS)

1. Health research governance structure in the country

In Yemen, there is not a formal national governance structure or mechanism nor a management or coordination mechanism of health research.

However, there are academic medical institutions (such as Aden and Sana'a) that carry out several research projects. The Yemen medical specialist council conducts health research.

Also, the Ministry of Public Health and Population has a general department of research and information whose functions include:

- Adopting health research policies, strategies and priorities
- Research of capacity building in the field of health research
- Documenting and disseminating research results
- Cooperating with local regional and international organization in the same field
- Conducting Health research projects

2. Management of the NHRS (structure(s), position(s) or organisation(s) involved)

Some of day -to -day management or coordination mechanism is carried out by the general department of health research and information of the Ministry of Health headed by the undersecretary of planning and development sector.

Its functions include:

- Supervising and monitoring of national health surveys and the provision of technical support
- National capacity building in the field of health research
- Cooperating with local regional and international organization in the same field

3. Existence of an 'office' for research within the Ministry of Health

At the Ministry of Health of Yemen there is a Centre of Research and Documentations.

There is no formal statement of NHRS values.

The Yemen NHRS has no system of monitoring and evaluation.
